President's Message

John Downton

I hope everyone had an enjoyable Christmas and I wish everyone a healthy and prosperous 2007.

This year our Board has a good balance of experienced people

and people who are new to the Board. Collective experience, together with fresh ideas, should make for an effective functioning Board. The success of our Association is dependent upon member participation and I invite Members to participate in the Association Committees of interest to them..

The objectives of the current Board are:

Improving on the pension indexing that came into effect in 2002: 60% of the Consumer Price Index (CPI) to a maximum of 1.2% for pensioners 65 years of age and over.

Enhancing the group health insurance benefit program through providing access to the latest available technologies that are also cost effective.

On the indexing issue, to date Tony Patey (Vice President and Chair of the Pension Action Committee) and I presented on behalf of our Association at the Provincial Government Pre-Budget Consultations in December 2006. Within this process we had an opportunity to present a brief; but ours was one of very many presented. This is a start but we realize that gaining benefits in this area will be very challenging. Amajor step will be getting our message heard by the Premier, the Minister of Finance and all other members of the House of Assembly. The Pension Action Committee is in the process of preparing materials and devising strategies for delivering this message. If any of you feel you can assist this committee in gaining the attention of each individual MHA, we would like to hear from you. Further information will be forthcoming from the Committee and will include activities planned around the budget process and the upcoming Provincial Election.

We continue to request enhancements to our Group Insurance Plan. The Group Insurance Committee is comprised of representatives from a number of Unions, the Managers' Association, Newfoundland and Labrador Public Sector Pensioners' Association, Health Boards, and the policy holder, Government. All of these groups have made requests for enhancements. These requests were given to the consultant, Mercer Human Resource Consulting, to cost out the addition of these enhancements to our Health Plan. Mercers have been working on this for some time and we hope that they will soon be ready to submit their analysis to us.

The change from Blue Cross to Desjardins as the new carrier still appears to have some administrative problems. However, the number of problems seems to be diminishing. As members of the Group Insurance Committee are made aware of problems, we are bringing these to the attention of appropriate parties for resolution.

I encourage Members to become involved in our Association and I look forward to meeting as many of you as possible over the coming year.

#### HIGHLIGHTS OF THE 16TH ANNUAL GENERAL MEETING

Taking Care of Business was the theme of the 16<sup>th</sup> Annual General Meeting & Conference. It was held on Tuesday, 17 October 2006 at the Comfort Inn, Airport Road, St. John's. Eighty members attended. President John Downton chaired the Conference.

Mr. Shawn Skinner, the Premier's Parliamentary Assistant, addressed the group and brought greetings from the Provincial Government.

The Keynote Speaker was Marilyn Pendergast, B.A., B.Ed, M.Ed, LLB. Ms. Pendergast gave an enlightening talk on Wills, Advanced Health Care Directives and Powers of Attorney, followed by a question and answer period.

Two Workshops which continued with the theme were offered:

Your Health Plan, presented by Tony Lannon, Director of Insurance Division and Ron Cashin, Service Representative and Jody Crowther, Account Manager for Desjardins They gave an update on the Desjardins Health Plan followed by a question and answer period.

*Your Pension Plan*, presented by David Lidstone, Pension Program Training Officer, and Kevin Murphy, CPP Client Services Officer. They gave an overview of the Public Service Pension Plan, the Canada Pension Plan and Old Age Security followed by a question and answer period.

The luncheon speaker this year was Susan Capps. Ms. Capps speech focused on her travels over the years.

Gerry Conran was made an Honorary Director of the Association and Tom Hanlon, Past-President of NAPE was made an Honorary Member in recognition of their extraordinary service to the Association.

REPORT OF THE PRESIDENT TO THE AGM ON BEHALF OF THE BOARD OF DIRECTORS: by Barbara Hopkins

On behalf of the Board of Directors I respectfully report on the activities of the Newfoundland and Labrador Public Sector Pensioners' Association (NPSPA) for 2005-06.

#### **MEMBERSHIP**

A Constitutional change in 2003 extended the membership to all persons and their spouses who are in receipt of a pension from any Pension Plan administered by the Provincial Government. Our data base shows a membership of 5835 with 305 new members being added during the year. We have been informed of 88 deaths. Hence, a small growth in membership. We do not have the addresses of members who have moved and have not let us know, so we have lost track of some 300 members. The Constitutional change of 2003 with respect to membership also opened the Association to people who were expecting to retire in five years. There are five members only in this category with none opting to join during the past year.

The Newfoundland & Labrador Public Sector Pensioners' Association exists to promote and advance the interests of its members by providing a medium for collaborative action on any matter affecting a pensioner's well being.

#### PENSION INCOME SPLITTING

Pension Income Splitting was announced by the Federal Government in the Fall of 2006 but will not apply until the 2007 tax year. Tax returns are generally filed between February and April so this option will be available in 2008. The Province announced that Pension Income Splitting would apply to Povincial personal income tax, as well as the Federal.

Pension income splitting is useful for married pensioners (including co-habitating couples) who are in different tax brackets. The couple can choose (or not) to split the pension income. Income (for tax purposes) can be transferred from the person with the higher income to the person with the lower income. It should be noted that this is simply a transfer on the tax return. No change will show up on pension cheques.

Details on this initiative will be released by the Federal Government. We will keep our members up to date via the Newsletter when we have the information.

#### LOW INCOME SENIORS' BENEFIT

The Newfoundland and Labrador Seniors' Benefit is a refundable tax credit for low income seniors. A refundable tax credit is an amount paid to an individual, even if they have no tax payable. The maximum credit for 2006 will be \$376 per senior, or \$752 per senior couple. The benefit will be gradually phased out as family net income increases from \$15,032 to \$21,482.

In order to qualify for this benefit, the person must be 65 years of age by December 31st of the taxation year. This benefit is paid in October of each year and is included in the same cheque as the GST/HST credit. The amount of the credit is based on family net income from the previous year.

More information about the Low Income Seniors' Benefit may be obtained by reviewing Section 34 of the Income Tax Act.


#### WESTERN BRANCH NEWS by Wesley Roberts

#### HOME HEATING REBATE

The Home Heating Rebate is available to residents of the Province whose household income in 2005 is \$30,000 or less and who incur costs to heat their home, regardless of the

primary source of heat.

A maximum rebate amount of \$200 is available to households with an income level of up to \$22,500. Individuals and families with income between \$22,500 and \$30,000 will also receive assistance; however the rebate will be reduced on a sliding scale. The minimum rebate an eligible



household will receive is \$100.

Eligible individuals or families must apply for the rebate, and must provide an electricity bill from November 2006 to April 2007 in the name of the applicant or the applicant's spouse. Family income is the net income of an individual, and where applicable, the net income of that person's spouse or partner. It is the net income from line 236 of the 2005 personal income tax return.

Special circumstances will be considered when calculating family net income. These include:

the surviving spouse's income for the year will be used to determine eligibility when a spouse has died

if a spouse resides in a long-term care facility, family net income will be reduced by the amount paid to support the spouse in the long-term care facility, and

if a person is enrolled in an Adult Basic Education or skills training program, net income will be reduced by the amount of the payments in respect of the ABE or skills training program.



#### LOW INCOME TAX REDUCTION

The Minister of Finance announced in the 2004 Budget that Government will be providing a provincial personal income tax reduction for low income individuals and families to be effective for the 2005 taxation year.

This credit will eliminate provincial income tax for individuals with net income up to \$12,000 and for families with net income up to \$19,000.

Partial tax reductions will be received by individuals with net income up to \$14,600 and for families with net income up to \$21,900.

At the ninth time he asks the little old lady why she is not eating the peanuts, whereupon she replies that she is unable chew them.




