

reetings from your Executive and Board.

The past few months have been very busy for your elected representatives, especially with consultation meetings with the Government on proposed changes or revisions to the Public Sector Pension Plan and other employee benefits, such as health care. Most of the work so far has dealt with the format or process in which this consultation will be managed.

The Annual General Meeting and 2013 Convention were held on October 04 and 05. This year's format was a little different from other years in that the Convention dealt with issues affecting seniors, such as affordable housing and homelessness, long term care, social issues and the rising concern of insolvency amongst seniors, in addition to concerns with our pension plan. All Convention topics were very much enjoyed by the delegates. The keynote address was given by Larry Brown, National Secretary-Treasurer, National Union of Public and General Employees (NUPGE). On a personal note, I did a presentation at our AGM and delivered the opening address of the convention. The AGM was also very informative of the past year's performance of the Association and was well received by the delegates.

This year's Convention has expanded the membership capabilities of NLPSPA by making changes to the Constitution to enable expansion in the categories of membership to include part time and temporary workers (casuals) and those employees who are in receipt of a pension that has a reciprocal agreement with the PSPP. More detailed information on these new membership opportunities are provided elsewhere in this newsletter.

Two long time Board members finished their terms of office at this year's AGM and Convention. Tony Patey our treasurer for many years and Sharon Callahan our past president will not be with us for this year's deliberations. We would like to thank both these members for their untiring work and dedication for the past number of years. We wish them well in all future endeavors and hope to see them back in the fold in the not too distant future. Tony and Sharron, thank you from all members of the Newfoundland and Labrador Public Sector Pensioners' Association. Two new Board members have joined us this year. They are Terry Dalton and Gerald Kennedy, both of whom were long term public sector employees. We look forward to them working with your Board and Executive.

Your Board of Directors looks forward to working with your Western and Central Branches in the coming year. Please make every effort to attend regional board meetings and support your Association.

More meetings with Government are tentatively scheduled for November and December with Government. We will keep you informed as information unfolds.

The annual Christmas Dinner and Dance for 2013 is being held on December 13th at the Knights of Columbus Building on St. Clare Avenue in St. Johns. Tickets are going fast so reserve yours early. A good time is assured all who attend.

Group Insurance Advisory Committee

For those members who were unable to attend our Annual General Meeting on October 4th at the Capital Hotel in St. John's, the following is the report I submitted on the activities of the Group Insurance Advisory Committee during the past year.

I am pleased to be able to continue to represent our Association on the Group Insurance Advisory Committee.

The role of this committee is to provide advice to the policyholder, the Provincial Government, through the Minister of Finance and to assist in the effective management of the Group Insurance Plan by monitoring the performance of the Plan and the insurance company administering it.

In 2013, the Group Insurance Plan was renewed effective April 1, with a revised rate implementation date of May 1, 2013. The most important aspects of the renewal changes are set out below. Supplementary Health Insurance:

The supplementary health insurance premium includes travel insurance. There was a 17.8% increase in the travel portion of the premium due to a significant rise in travel and associated claims. The increase represented approximately 0.2% of the total supplementary health premium. The increase in the supplementary health was 3.1%. Therefore the combined supplementary health and travel insurance increase was 3.3%,

Effective May1, 2013, the semi-monthly payroll deduction for supplementary health insurance, including travel insurance increased by \$0.61 for single coverage and \$1.52 for family coverage. The new semi-monthly deductions for supplementary health insurance is \$19.25 for single coverage and \$48.67 for family coverage.

Optional Dental Insurance:

Prior to the 2013 renewal, dental expenses were reimbursed on the 2011 Newfoundland and Labrador Dental Association Fee Guide. As of May 1, 2013 the dental plan now reimburses expenses based on the 2013 Fee Guide. This resulted in an increase of 2.1% in the dental premiums.

Effective May 1, 2013 the semi-monthly payroll deduction increased by \$0.30 for single coverage and \$0.65 for family coverage.

In addition to the above information I can report that during the past year a number of interesting queries were raised by members and I hope I was able to provide them with information that was of assistance.

Advance Health Care Directive

On October 8, I attended the announcement by the Coalition of Persons with Disabilities (COD-NL) of the Advance Health Care Directives education initiative. The launch of this initiative was done by His Honour Frank F. Fagan, Lieutenant Governor of Newfoundland and Labrador, as patron of COD-NL, to raise awareness of and promote consideration of the Advance Health Care Directive throughout our Province.

What is an Advance Health Care Directive? It is a document in which you explain your wishes about health care and treatment when you are not able to make decisions or communicate them at a future time. The directive is a legal document that must be followed except in limited circumstances, such as asking someone to do something that is against the law.

As long as you are able, you have the right to exercise your choice of health care. When you are not able, having your wishes documented so they can be communicated to the health care system is the best alternative to still having your choices respected. If you do not have an Advance Health Care Directive, consider doing so. This is not something only for the very elderly; it is important to any person of any age.



A Synopsis of the 23rd Annual General Meeting and 2013 Convention

Your Issues-Your Solutions: Pensioners, Retirees, Aging Persons, and Seniors Talking About Life's Issues

hat a great event! Best \$50 I ever spent! These are two of the predominant comments found on the evaluation forms of the 2013 Convention of the Newfoundland and Labrador Public Sector Pensioners' Association. As the Annual General Meeting was held immediately following the Opening Ceremonies on Friday night, the two events, while separate, were found to be interesting, motivating, enjoyable, and well worth the effort to attend by those who participated. Held at the Capital Hotel in St. John's from October 4-5, 2013, the organizers built upon the feedback from last year's AGM and Convention and with some modifications delivered a program that was timely and appropriate in addressing the issues of concern to retired persons and seniors in our Province.

The program of the Convention commenced with registration on Friday evening (the 4th), followed by a social, and the Opening Ceremonies. The Chair of the Planning Committee was the Conference Coordinator and Sharron Callahan welcomed everyone to the event. The singing of O Canada opened the evening, followed by greetings from the President, Ralph Morris, an Invocation by Clayton Rice, greetings from His Worship, Mayor Dennis O'Keefe, City of St. John's, a moment of silence for deceased members and an update from President Ralph on recent talks between the Public Sector Pension Plan stakeholders and the Provincial Government. The agenda was altered somewhat at this juncture to accommodate the delayed arrival of our keynote speaker, Larry Brown, who this evening was intending to set the stage by providing an introduction to his key topic of the following morning. The Annual General Meeting then commenced at the publicized time of 7:00 PM.

The Annual General Meeting, under the Chair of President Ralph, highlighted the happenings, the business, and financial circumstances of the Association during the past year. NLPSPA has had a very positive year, the financial circumstances of the Association have stabilized and are well on the road to recovery, our re-positioning to be inclusive of all pensioners and other retirees is happening through the Coalition for which a new Charter has been developed and outreach is continuing, messaging to members was significantly improved, regular newsletters were published and a Facebook and Twitter account were launched, advocacy against the public mischaracterizations of pensioners as the cause of the financial woes of the Province was elevated to a higher level of redress, and talks resumed with Government on their proposals to consider changes to the PSPP and other Post-Employment Benefits. It was noted that our partnership with Anthony Insurance continues to be very strong and an extension of our funding Agreement is in discussion.

Many thanks are extended to Tony Patey and Craig Pendergast for their contributions to the Association. Special thanks were offered to Sharron Callahan who retires this meeting from the Board after many years of service. Sharron was named a Honourary Director. The Association welcomes Terry Dalton and Gerry Kennedy who were elected as Directors of the Board. As Larry Brown had arrived at this time, Larry closed the evening with his thoughts about what is happening with Pension Plans around the world and in Canada and left everyone anxious for his full address the next morning.

On Saturday, October 5th, the Convention got under way following the welcome and usual housekeeping matters. Larry Brown, National Secretary Treasurer of the National Union of Public and General Employees gave a very dynamic and challenging address to the delegates on why pensions are under so much attack today and what each of us, as individuals and as a collective, should do to counter this onslaught. With limited time remaining, Larry








Faithful and Fearless

New Membership Opportunities in NLPSPA

t the Annual General Meeting of the Newfoundland and Labrador Public Sector Pensioners' Associa-Lation on October 4, 2013, two amendments were approved to the Association's Constitution to facilitate membership for more persons who either worked directly for the Newfoundland and Labrador Government or for another Government or organization who had a direct relationship with the provincial government via a reciprocal agreement with the public service pension plan (PSPP). The new categories of membership include an expansion of Voting Membership to include those persons in receipt of a pension from the Government Money Purchase Plan and by adding a new category of Non-Voting Membership to include those persons in receipt of a pension from a pension plan that has a reciprocal agreement with the PSPP. While there will be administrative challenges for the Association in reaching out to these potential new members, any assistance that our current readers can offer by directing any persons in these two categories to the NLPSPA Office would be greatly appreciated.

To further clarify, a reciprocal member would also include those persons who worked for an agency that had a reciprocal agreement with Government, even though that listing may no longer be valid as the agency no longer exists (examples include former Janeway Hospital Private Pension Plan, Versa Services). Should this listing of reciprocal agreements change any time into the future or NLPSPA become aware of any missing reciprocal agreements from this list, a correction will be advised.

We have a lot of work ahead of us, but are pleased that the membership chose to expand the opportunities for many other government workers to avail of the benefits of membership in NLPSPA, especially the advocacy work that is ongoing to better living into retirement that we all so rightly deserve and worked so hard to achieve.

Regular Members: \$1.00 per pay period, deducted from pension cheques on a bi-monthly basis by the Department of Finance, Pensions' Division, upon receipt of pensioner's membership application from NLPSPA Office.

Affiliate Members: \$24.00 annually payable to NLPSPA at the time of membership application and subsequently upon receipt of annual invoice until eligible for regular membership.

Associate Members: No membership fee for spouses/partners of Regular and Affiliate Members.


