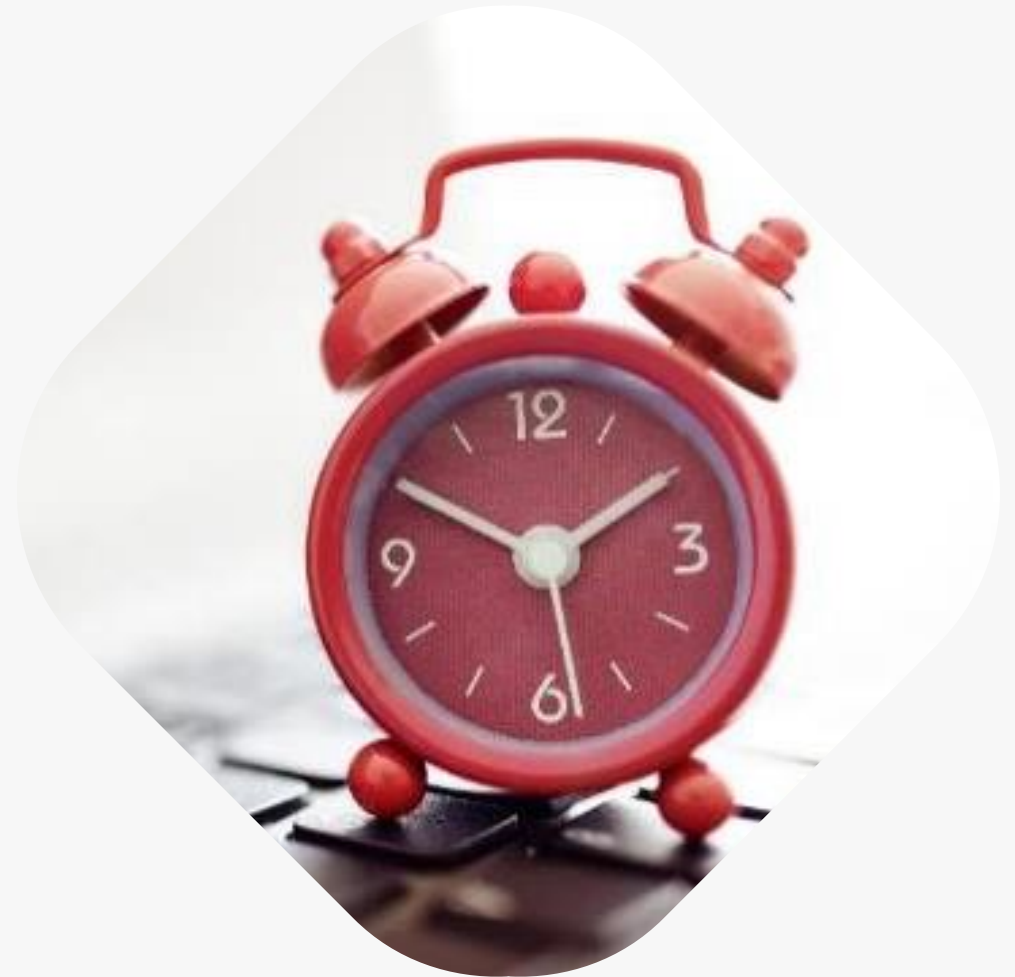

Do your taxes on time

- Information from your tax return is used to calculate your benefit and credit payments (such as the CCB)
- Avoid payment delays by doing your taxes **on time**
- Deadline to file is **April 30**



Free tax help

The Community Volunteer Income Tax Program (CVITP) is a collaboration between:

- the Canada Revenue Agency (CRA), and
- community organizations and their volunteers

In Quebec, the program is called the Income Tax Assistance – Volunteer Program.

Who is eligible for the CVITP?

Suggested family income	
1 person	\$35,000
2 people	\$45,000
3 people	\$47,500
4 people	\$50,000
5 people	\$52,500, plus \$2,500 for each additional person

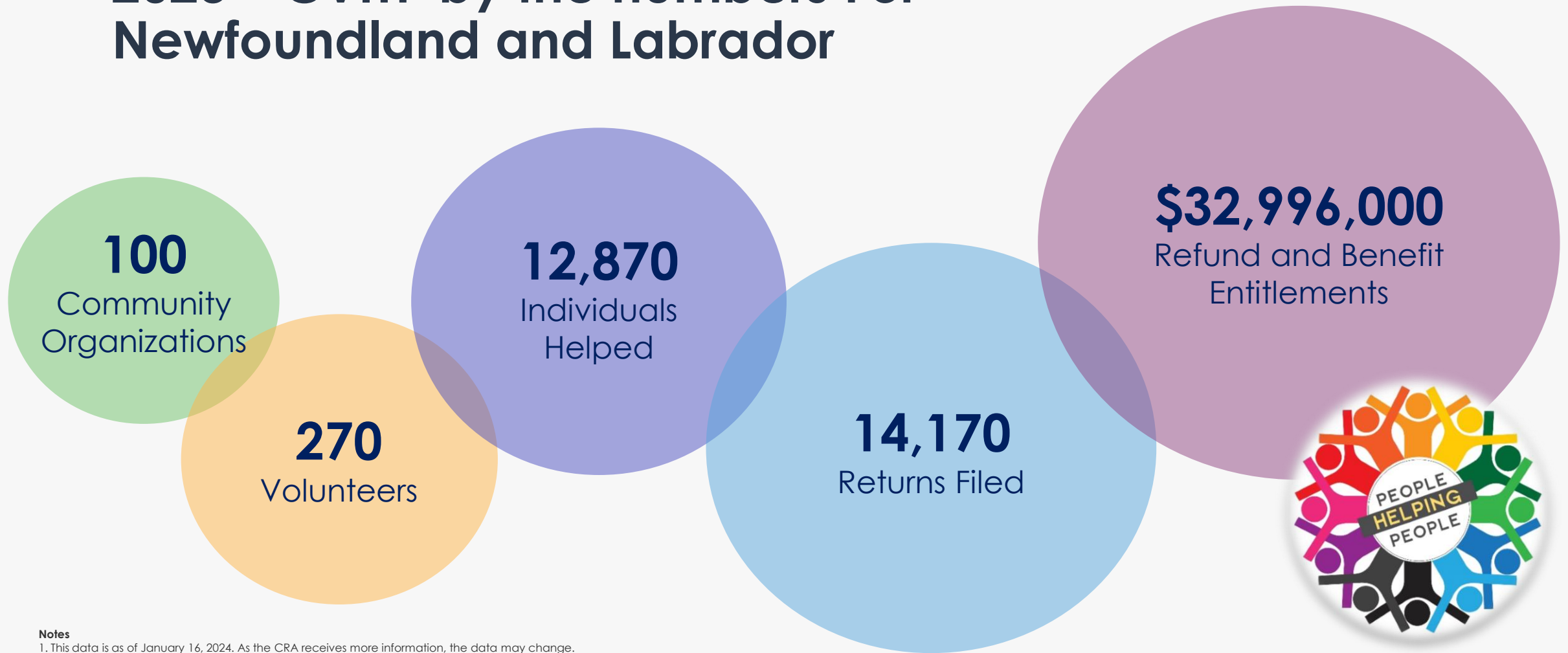

Notes

1. This data is as of January 16, 2024. As the CRA receives more information, the data may change.

2. Refund and benefit entitlement amounts are from federal and provincial benefits administered through the CRA. The amounts apply to current and prior-year income tax and benefit returns filed through the CVITP from January 1, 2023 to December 31, 2023.

3. The listed province/territory is where the individual was a resident on December 31, 2023, as reported on their return. An individual can have multiple returns (current and previous years) filed under more than one province or territory. Provincial/territorial totals will not add up to national totals. This is because national totals include counts for those whose province/territory of residence could not be identified when the data was gathered.

4. All data have been rounded. Amounts are from federal and provincial refund, credit, and benefits administered through the CRA and do not include the provincial data from Quebec.

5. The national totals for individuals helped, returns filed, and refund and benefit entitlements include information from individuals who are classified as "outside Canada" and "unspecified." These classifications are for those who lived abroad at the time of their most recently filed return and whose mailing province code was blank in the CRA system. As a result, the national totals will not match the sum of the regional totals.

GST/HST credit

Helps those with low and modest income offset the tax they pay on goods and services.

Individual:

Up to \$496 per year

Married or have a common-law partner:

Up to \$650 per year

For each child under 19:

Up to \$171 per year

Canada Carbon Rebate (CCR) (formerly known as the Climate action incentive payment)

Help individuals and families offset the cost of federal pollution pricing.

The amount you receive depends on:

- your family situation
- the province where you reside

Canada child benefit

A tax-free monthly payment made to help with the cost of raising children under 18 years of age.

Children under 6

Up to \$7,437 per child, per year

Children 6+

Up to \$6,275 per child, per year



Canada workers benefit

Provides a financial boost to those in the workforce and earning a low income.

Individual:

Up to \$1,518 per year

Family:

Up to \$2,616 per year

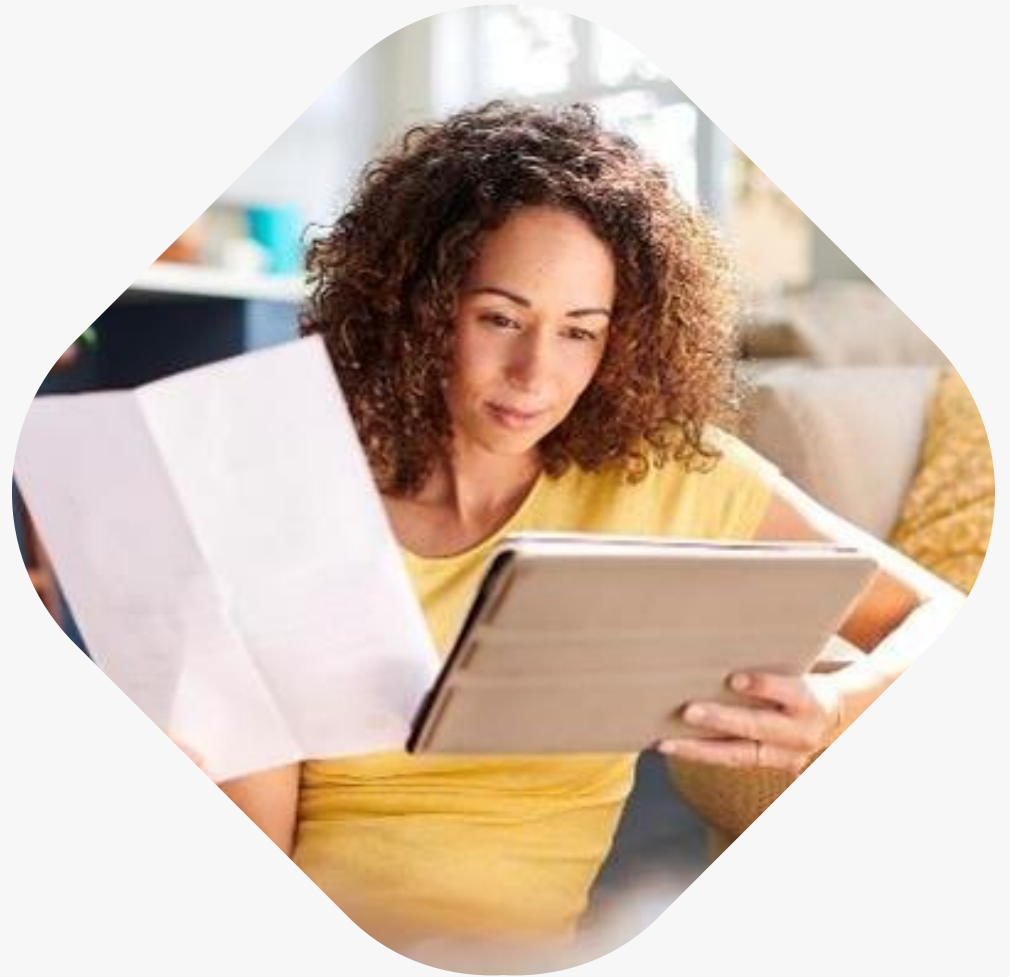
